TWO OR MORE RACES (Not of Hispanic or Latino) – All persons who identify with more than one of the above five races.

Veteran's Preference. Great Falls College MSU complies with the Montana Veteran's Employment Preference Act and provides preference in employment to eligible veterans, disabled veterans and certain eligible relatives as specified in the Act.
