GFCMSU Childcare Scholarship Application Instructions and Form

The GFCMSU Childcare Scholarship Program at Great Falls College MSU centralizes numerous endowed scholarships and donations for childcare scholarships into a single application form. Awarded funds, ranging from \$250-\$500 per semester, per student, are designated ONLY to support your child or children's childcare expenses at TLC Center located at GFCMSU while you are enrolled at GFCMSU. If selected, the scholarship amount will be credited to the student's family account at TLC Center. A scholarship committee will match qualified applicants with available scholarships.

ELIGIBILITY

GFCMSU Childcare Scholarship awards recognize students who:

- Are currently enrolled at Great Falls College MSU.
- Have at least one child concurrently enrolled at TLC Center at GFCMSU – must provide name(s) of child(ren). Must be confirmed by the Director of TLC.
- Maintain a 2.5 grade point average or above.
- Demonstrate a need for childcare support. (See Personal Statement)
- Demonstrate a personal commitment to scholastic pursuit at GFCMSU.
- Meet additional requirements as determined by each available scholarship. (See individual scholarship requirements below)

SCHOLARSHIP AWARDS

- The **Knud and Kathrine Grosen Scholarship** will total up to \$1000 per academic year. Must be currently enrolled at GFC MSU as a 2nd year student.
- The **Dr. Charles and Gerry M. Jennings Scholarship** will total up to \$1000 per academic year. Must be currently enrolled at GFC MSU as a first or second year student. Must maintain a 2.8 grade point average or above. Given to students enrolled in Nursing. **Additional funds may be available toward tuition.
- The **Roland and Helen Lapee Family Foundation Scholarship** will total up to \$1000 per academic year. Must be currently enrolled at GFC MSU in a program of study rather than incidental coursework. Preference given to students enrolled full time.
- The **Janie and Stuart Nicholson Scholarship** will total up to \$1000 per academic year. Must be currently enrolled at GFC MSU as a second year student.
- The **Pacific Steel & Recycling Scholarship** will total up to \$1000 per academic year. Must be currently enrolled at GFC MSU in a program of study rather than incidental coursework. Preference given to students enrolled full time.
- The **General childcare Scholarship** will have a variable allocation per academic year depending on funds available. Must be currently enrolled at GFC MSU as a first or second year student.

1. **Scholarship Application:** Complete the application form in its entirety.
2. **Personal Statement:** Describe the program of study you are pursuing and the specific qualities you possess that demonstrate your genuine interests in completing your academic and scholarly pursuit at GFCMSU. Please limit to one page.
3. **Letter of Recommendation:** Submit ONE letter from an instructor of yours in your area of study. The letter MUST include the name, address, email, telephone number, and signature of the GFCMSU faculty member making recommendation.
4. **Current Unofficial Transcripts:** Provide your most current college transcripts.
